

Ans: A strong answer will include identifying the various forms of body modification, which include, but are not limited to extreme tattooing, piercings, and so on. Mr. Lepperd paid to have more than 99 percent of his body covered in inked leopard spots. He is deviant because he violates the social norm of having only a few tattoos, and is practically covered. Body modification also includes piercings, scarification, and reconstructive and cosmetic surgery.

How did this impact the children?

Ans: Yearning for Zion Ranch & legal intervention

SWAT teams raided ranch and forcibly removed more than 400 children from their homes and families; Texas child welfare officials believed children were in danger.

- Young girls were being made into child brides.
- Physical and sexual abuse was occurring.

Children were separated from parents for 2 months while investigations took place and forced to accept a new set of norms (strangers, foods, clothing, etiquette).
